Minutes of the meeting held on 27th October, 2025 under the chairmanship of DG, NMCG to review the progress of Narmada river basin under the Condition Assessment & Management Plan (CAMP)

A meeting to review the progress of Narmada river basin under the Condition Assessment & Management Plan (CAMP) was held on 27th October, 2025 under the Chairmanship of DG, NMCG & PD, NRCD at O/o NMCG, National Dhyan Chand Stadium, New Delhi. A list of participants who attended the meeting is annexed.

- 2. JS, NRCD, DoWR, RD & GR welcomed all the participants and made a presentation indicating the status of deliverables of the Consortium Institutes (CIs) viz. cGanga, IIT, Gandhinagar and IIT, Indore and fund utilization upto September, 2025 for Narmada River basin and further action to be taken.
- 3. It was observed that there is hardly any progress since last meeting and coordination issue still persists. PD, NRCD highlighted the issues pending regarding finalization of the reports and directed for following action:
 - a) To nominate officers of NRCD as nodal officer for each of the six river basins for coordination purposes.

(Action: All Cls, NRCD)

b) All the basin States to update the nodal officers for the State Departments and the State Pollution Control Board/ Committee for providing timely comments.

(Action: Basin States MP and Gujarat)

c) To create basin-wise whatsapp group for smooth monitoring of the project and add all CIs, cGANGA, respective State nodals and NRCD nodals.

(Action: NRCD)

d) It was informed that following have been nominated as Nodal officers from States:

State of Madhya Pradesh

- i. Shri Sitaram Tagore, UD Department, Govt. of MP
- ii. Smt. Rajkumari, MPCCB and
- iii. Shri Ankit Dalal, AE.

State of Gujarat

- i. Shri Shubham Goel, Chief Engineer
- ii. Shri D.C. Thakkar, Canal Officer
- e) PD, NRCD directed that NRCD may organize a meeting with the Cls and all nominated nodal officers from each basin to clearly define their roles and responsibilities. He also directed that all kind of communications should go to nodal officers only.

(Action: NRCD)

- 4. Cls informed that reports on 19 deliverables have already been sent to State Governments, it was observed that no action has been taken by the State of Madhya Pradesh and Gujarat on these reports. PD, NRCD directed the following:
 - a) Cls to follow up the reports sent by them to States and get action expedited on it. NRCD shall also send the reports to States concerned for comments/ action.

(Action: All Cls/ NRCD, cGanga)

b) KLM file should be made for all River Atlas.

(Action: All Cls/ cGanga States)

c) In the presentation, it is observed that while presenting the funds released and expenditure status, partial Utilization Certificates (UCs) submitted has been shown. PD, NRCD directed to also include UCs submitted in one additional column in the slide also, for future meetings.

(Action: States/ Cls/ NRCD)

- d) cGanga to update the categorization of deliverables as follows:
 - i. Report under preparation
 - ii. Draft report
- iii. Final report
 - e) He further directed States that mapping of CPCB reports/ stations on polluted river stretches may also be done.

(Action: States of MP and Gujarat)

f) The CIs were directed to finalize the deliverables upto last quarter of Sept,2025 on priority and at the earliest.

(Action: Cls)
